This is an application and agreement for credit and shall apply to any and all credit extended by ProAble Hardware Specialties Inc. The credit applicant understands and agrees to the following terms and conditions of sale:

- 1 Terms of sales are **Net 30 Days**. All invoices must be paid in full. No unauthorized deductions and no unauthorized returns. Agents or representatives of ProAble Hardware Specialties Inc. are not authorized to change or adjust credit terms without written authorization of the Finance Manager.
- 2 Accounts not paid by the due date are subject to interest charges from the date of maturity at the rate of **1.5% per month (18% per annum)** as shown on invoice/statements.
- 3 Further Shipments may be withheld on overdue balances.
- 4 All claims against invoices must be made within **5 Working Days** after receipt of goods.
- 5 An Order will NOT be processed until your Purchase Order Number or Written Authorization To Proceed is received.
- 6 On shipments made by common carrier consigned to the customer, all claims for damages in transit must be filed by consignee.
- 7 We do not include cost of unloading, storage or protection of material at jobsite.
- 8 Material will be billed proportionately as shipped.

- 9 Goods/Merchandise must be authorized for return by ProAble Hardware Specialties Inc. and will be subject to a **Minimum 25% restocking charge**. Non stock product is subject to a ProAble Hardware Specialties Inc. restocking charge, the suppliers restocking charge and any related material handling costs. Non stock product that cannot be returned to the supplier is not returnable. Product is not returnable if it is not in original condition.
- 10 Under no condition will a Back Charge be accepted for any reason unless it is approved prior to it being performed by any Sub Contractor. Approvals for any type of Back charge must be sent in writing addressed to the Finance Manager of ProAble Hardware Specialties Inc.
- 11 **N.S.F. cheques will be subject to a \$25.00 charge.**
- 12 Failure to comply with these terms and conditions may result in cancellation of credit privileges without notice.
- 13 The applicant agrees to promptly notify ProAble Hardware Specialties of any changes in the applicant's business name, address or chief place of business.
- 14 The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for, or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit agency or to any person with whom the applicant has or purposes to have financial relations.
- 15 We may request updated credit information if your account remains dormant for six months or more.
- 16 In no way shall the applicant hold ProAble liable for any delays in delivery of product and/or services quoted.
- 17 Should the applicant default in payment of its outstanding account, or should a default be declared, then Pro-Able Services shall be entitled to incur expenses and/or the cost of collection and this amount shall be added to the unpaid balance of the applicants account and shall be due and owing from the applicant to ProAble Hardware Specialties Inc.
- 18 Pro-Able Hardware Specialties Inc. acceptance of partial or delinquent payments or failure of ProAble Hardware Specialties Inc. to exercise any right or remedy shall not be a waiver to any obligation of applicant or right of ProAble Hardware Specialties Inc. nor constitutes a modification of the agreement nor constitute a waiver of any other similar default subsequently occurring.
- 19 The provisions of this agreement are hereby made applicable to and shall ensure to the benefit of ProAble Hardware Specialties Inc. successors and assigns and bind the applicants, heirs, legatees, devisees, administrators, executors, successors, and assigns.
- 20 This agreement shall be governed and construed in accordance with the laws of the Province of Ontario. In the event that any of the provisions of this agreement shall be held by a Court of Competent Jurisdiction to be unenforceable the remaining provisions of the agreement shall remain in full force and effect. In the event of the invalidity of any clause herein the clause shall be deemed severed and the balance of this agreement shall be enforced.
- 21 It is the express wish of the parties that this agreement and any related documents be drawn up and executed in English.
